**1 Congratulations and welcome to new Clerk**

All councillors welcome the new clerk, Jordan Griffiths, to his role.

**2 Apologies**

None

**3 Declarations of Personal Interest (Verbally)**

Declarations by members of personal interests made verbally.

**4 Minutes of the Last Meeting**

The minutes of last meeting held on the 4<sup>th</sup> of November 2020, was accepted as true record on the proposal of Cllr A. Dady, seconded by Cllr W. Churchill.

**5 Finance Committee Report**

Two reports were received, the latest of which was from a meeting on the 2<sup>nd</sup> of December 2020. Cllr H. Taylor noted a mistake in the initial minutes that was corrected. Terms of reference are in the process of being written. Application form for financial assistance has been drafted and disseminated to members of the finance sub-committee with the contact details of the new clerk. The finance sub-committee are happy with the draft and it has been accepted. Budget for office equipment was discussed and Jordan Griffiths had been tasked with finding a price for a computer. Jordan has found a computer costed at £529 from Currys. Cllr. T Strutt noted how Jordan should source all of the equipment for a new office, Cllr H. Taylor stated that she'd given instruction to find laptop only as a decision had not been made on an office yet. Cllr T. Strutt proposed that we purchase the laptop, seconded by Cllr A. Roberts, all councilors voted in favour.

Cllr H. Taylor had been in contact with Paul Hinder in order to ascertain the exact process of the Celtic energy grant. Celtic energy decided to allocate £50,000 to local areas, including Cwarter Bach. All local and community councilors were present at a meeting in 2016, NPT

council thought they had a say in where the money was allocated but this was not the case. Celtic Energy further allocated £275,000 to NPT council to be distributed to councils that have requested it. There is still roughly £90,000 left. There have been 5 awards in Cwarter Bach, Dec 2016 £10,000 to Ystradowen community center for kitchen refurbishment. Sept 2017 £4,863 to convert a sitting room into an internet café at Ystradowen community center. Nov 2017 £4,634.16 to Ystradowen community center for kitchen equipment. Nov 2019 £7,272.82 to Ystradowen community group for one of their green spaces. Also grant to Black Mountain Centre in Nov 2016 £7,808 for refurbishment of carpet and kitchen, Sept 2020 £4,800 for outside canopy.

Cllr H. Taylor noted that NPT were not rejecting grant applications because CBCC had not spent the original £50,000, Cllr J.G Davies agreed with this. Cllr T. Strutt questioned how the totals for the Ystradowen community centre, which Cllr J. G. Davies then clarified the figures. Cllr J. G. Davies clarified that the original £275,000 was not split equally between eligible areas, and that instead it was on a first come first serve basis. Cllr H. Taylor stated that the maximum per grant application was £10,000.

Cllr D. Belcher claimed an ex councilor had been refused financial assistance for a project. A debate ensued on the purpose of the purpose of the £50,000. Cllr T. Strutt mentioned that CBCC should decide what to spend the £50,000 on. Cllr H. Taylor and J. G Davies restated that Paul Hinder had said that the original £50,000 had no effect on future grant applications. Cllr H. Taylor agreed with Cllr T. Strutt that the council should now decide what to spend the original £50,000. Cllr. J. G Davies clarified the process of applying for a portion of the £275,000 from NPT council and that it is a process separate to Cwarter Bach Community Council.

Cllr. J. G. Davies asked if the £50,000 was in a separate account, Cllr. H Taylor said that this what not the case. She also stated that CBCC have a lawful responsibility to spend this money and that the previous auditors stated the council had too much money. As a result, Cllr H. Taylor also suggested the council decide how to best spend the money. Cllr H. Taylor proposed that the council agree to begin exploring how to spend this money and do this by asking the community what they would like the money to be spent on, Cllr W. Churchill agreed. Cllr. H Taylor asked for suggestions from councilors as to how the money is spent, and that the finance sub-committee look at the logistics of spending this money.

## **6 Asset sub-committee report**

Cllr. T Strutt presented asset sub-committee report. They are waiting to hear from Pride in the Community regarding terms of reference.

Clerk and Cllr. T Strutt to meet and discuss all assets and discuss what needs to be done. Cllr. T Strutt relayed the quotes that had been sent by Wrenvale for various items and asked for approval to spend this money, to which quotes were agreed between Wrenvale and Cllr. T. Strutt. Proposed by Cllr. S Thomas, seconded by Cllr. A Hicks, all councilors voted in favour.

Inspection of Bryn Rovers changing rooms to be done tomorrow (10<sup>th</sup> Dec), County Council not prepared to send out contractor due to insurance issues. Cllr. T Strutt sought permission to instruct the clerk to make a claim on the insurance for the changing rooms as the damage was caused by a leak. The council agreed to pursue this.

Cllr. T Strutt noted how Bryn Rovers had sent a document replying to CBCCs concerns and asked councilors to comment on it to present to Bryn Rovers at the next meeting.

Cllr. H Taylor updated the CBCC on the Maes Elwyn site. A sub-group was set up and went through the project in significant detail, and a report was made. The sub-group recommended to the asset sub-committee that the project should not go ahead. Cllr. H Taylor then read the concerns of the councilors about the project. Cllr. W Churchill also relayed her concerns about the financial implications of the project. Cllr. H Taylor proposed a vote on accepting the recommendations of the asset sub-committee and will review the project at a later date, all councilors voted in favour of this.

## **7 Pride in the Community report**

Cllr. W Churchill presented the report. She noted how the committee would like to change its name to “Community Pride” and read out the new terms of reference for the committee. The committee has a budget of £8,000 to be spent during the financial year. Membership of the committee is as follows: Cllrs. A Hicks, H Powell, V Morgan and W Churchill.

Cllr. A Hicks noted that Nigel (Wrenvale) would repaint the pots for free and was quoted as replanting each box at £20 a box, 8 in total, to come out of the Community Pride budget. Cllr. T Strutt asked for clarification on how the budget would work, Cllr. H Taylor noted that this was a discussion to be had separately. Cllr. W Churchill noted how that once each sub-committee had its terms of reference, the ‘overlap’ and ‘grey areas’ would be cleared up.

Cllr. W Churchill stated how the Community Pride sub-committee will work to involve the community in their work as much as possible, including holding local events.

## **8 Initial budget for office equipment and training for new clerk**

Cllr. H Taylor noted what the CBCC had agreed to spend, including membership of the SLCC, costing £178 and the ICLA qualification, costed at £99 which is to be completed in the first 6 months. Jordan Griffiths must also apply for the CILCA after 12 months of work. Total training budget of £500-£600 to contribute to these and for One Voice Wales modules. Cllr. H Taylor proposed, seconded by Cllr. A Roberts, all councilors voted in favour.

Membership of SLCC, proposed by Cllr. J. G Davies, seconded by Cllr. W Churchill, all councilors in favour.

Cllr. A Roberts mentioned the support of an accountant for this first year, it would cost £120 to set up pension. Cllr. H Taylor proposed the support of an accountant and the support of a local, experienced clerk for the first year of Jordan’s role.

Support of accountant and mentor, proposed by Cllr. T Strutt, seconded by Cllr. D Belcher, all councilors in favour.

## 9 **Office Accommodation**

Cllr. H Taylor proposed taking advantage of low rates for Black Mountain Centre and Ystradowen community centre and noted the importance of having a base at both ends of the community. Cllr. A Hicks stated that there isn't a need for two offices and stressed the importance of having an office for the sole use of the clerk. Cllr. T Strutt noted the importance of having centers in both Brynamman and Ystradowen. Cllr. A Dady agreed with the proposition by Cllr. H Taylor.

Cllr. W Churchill proposed, seconded by Cllr. A Dady, split between Black Mountain Centre and Ystradowen Community Centre with the main office to be in Brynamman, all councilors voted in favour.

## 10 **Tennis courts and information boards Cefnbrynbrain**

Cllr. T Strutt noted that this could be deferred to asset sub-committee.

## 11 **Highway traffic mountain road/cwmgarw road**

Cllr. A Hicks expressed concerns over speeding in the area. She asked if the CBCC could raise the issues with Dyfed Powys Police. Cllr. J. G Davies noted a public consultation undertaken years ago which resulted in chicanes being placed. He also stated that he has spoken to the police and has suggested speed bumps be placed. Cllr. A Hicks recommended CBCC send a letter to Dyfed Powys Police to highlight the issue of speeding on Mountain Road.

Council instructed the clerk to contact Dyfed Powys Police to organize a meeting to discuss the problem.

Cllr. T Strutt suggested getting the support of other local community councils in order to address the issue

## 12 **Correspondence**

Cllr. H Taylor noted correspondence asking for horse riders to have access to the cycle path. Cllr. J. G Davies explained how this is the responsibility of County Council, and if the council wished, they would have to send a letter with a recommendation to Carmarthenshire County Council. Cllr. H Powell explained how the cycle path is very busy with pedestrians and dog-walkers and did not support allowing horse riders to use the cycle path. Cllr. T Strutt agreed with this. The CBCC were against supporting the riding of horses on the cycle path. The clerk will write a response to this letter.

13 **Bank Account**

Cllr. A Roberts asked for new signatories for the bank account. Cllrs. A Roberts, H Taylor, T Strutt, D Belcher, J. G Davies, W Churchill were approved as the signatories.

**5 Adroddiad Pwyllgor Cyllid**

Derbyniwyd dau adroddiad, y diweddaraf ohonynt o gyfarfod ar yr 2il o Ragfyr 2020. Nododd Cllr H. Taylor gamgymeriad yn y cofnodion cychwynnol a gywirwyd. Mae cylch gorchwyl yn y broses o gael ei ysgrifennu. Mae'r ffurflen gais am cymorth ariannol wedi'i drafftio a'i dosbarthu i aelodau'r bwyllgor cyllid gyda manylion cyswllt y clerc newydd. Mae'r bwyllgor cyllid yn hapus gyda'r drafft ac mae wedi'i dderbyn. Trafodwyd y gyllideb ar gyfer offer swyddfa ac roedd Jordan Griffiths wedi cael y dasg o ddod o hyd i bris am gyfrifiadur. Mae Jordan wedi dod o hyd i gyfrifiadur wedi'i gostio ar £529 gan Currys. Nododd Cllr T Strutt sut y dylai Jordan ddod o hyd i'r holl offer ar gyfer swyddfa newydd, nododd Cllr H. Roedd Cllr H. Taylor wedi bod mewn cysylltiad â Paul Hinder er mwyn canfod union broses y grant ynni Celtaidd. Penderfynodd ynni Celtaidd ddyrannu £50,000 i ardaloedd lleol, gan gynnwys Cwarter Bach. Roedd yr holl gynghorwyr lleol a chymunedol yn bresennol mewn

cyfarfod yn 2016, roedd cyngor NPT o'r farn bod ganddyn nhw lais o ran dyrannu'r arian ond nid oedd hyn yn wir. Dyrannodd Celtic Energy £275,000 ymhellach i gyngor NPT i'w ddsbarthu i gynghorau sydd wedi gofyn amdano. Mae tua £90,000 ar ôl o hyd. Bu 5 gwobr yn Cwarter Bach, Rhagfyr 2016 £10,000 i ganolfan gymunedol Ystradowen ar gyfer adnewyddu cegin. Medi 2017 £4,863 i drosi ystafell eistedd yn gaffi rhyngwyd yng nghanolfan gymunedol Ystradowen. Tach 2017, £4,634.16 i ganolfan gymunedol Ystradowen ar gyfer offer cegin. Tach 2019, £7,272.82 i grŵp cymunedol Ystradowen ar gyfer un o'u lleoedd gwyrdd. Nododd Cllr H. Taylor nad oedd NPT yn gwrthod ceisiadau grant oherwydd nad oedd CBCC wedi gwario'r £50,000 gwreiddiol, cytunodd Cllr J.G Davies â hyn. Cwestiynodd Cllr T. Strutt sut roedd y cyfansymiau ar gyfer canolfan gymunedol Ystradowen, a eglurodd Cllr J. G. Davies y ffigurau wedyn. Eglurodd y Cynghorydd J. G. Davies nad oedd y £275,000 gwreiddiol wedi'i rannu'n gyfartal rhwng ardaloedd cymwys, a'i fod yn lle y cyntaf i'r felin. Dywedodd Cllr H. Taylor mai'r uchafswm fesul cais am grant oedd £10,000.

Honnodd Cllr D. Belcher bod cyn gynghorydd wedi cael ei gwrthod am cymorth ariannol ar gyfer prosiect. Cafwyd dadl ar bwrpas pwrpas y £50,000. Soniodd Cllr T. Strutt y dylai'r CBCC benderfynu beth i wario'r £50,000 arno. Ailddatganodd Cllrs H. Taylor a J. G Davies fod Paul Hinder wedi dweud nad oedd y £50,000 gwreiddiol yn cael unrhyw effaith ar geisiadau grant yn y dyfodol. Cytunodd Cllr H. Taylor gyda'r Cllr T. Strutt y dylai'r cyngor nawr benderfynu beth i wario'r £50,000 gwreiddiol. Eglurodd Cllr J. G Davies y broses o wneud cais am gyfran o'r £275,000 gan gyngor CNPT a'i bod yn broses ar wahân i Gyngor Cymuned Cwarter Bach.

Gofynnodd Cllr J. G. Davies a oedd y £50,000 mewn cyfrif ar wahân, dywedodd Cllr. H Taylor mai dyma beth nid yr achos. Dywedodd hefyd fod gan CBCC gyfrifoldeb cyfreithlon i wario'r arian hwn a bod yr archwilwyr blaenorol wedi nodi bod gan y cyngor ormod o arian. O ganlyniad, awgrymodd Cllr H. Taylor hefyd y dylai'r cyngor benderfynu sut i wario'r arian orau. Cynigiodd Cllr H. Taylor y dylai'r cyngor gytuno i ddechrau archwilio sut i wario'r arian hwn a gwneud hyn trwy ofyn i'r gymuned beth yr hoffent i'r arian gael ei wario arno, cytunodd Cllr W. Churchill. Gofynnodd Cllr H Taylor am awgrymiadau gan gynghorwyr ynghylch sut mae'r arian yn cael ei wario, a bod yr bwyllgor cyllid yn edrych ar logisteg gwario'r arian hwn.

Trosglwyddodd Cllr T Strutt y dyfyniadau a anfonwyd gan Wrenvale ar gyfer amrywiol eitemau a gofynnodd am gymeradwyaeth i wario'r arian hwn, y cytunwyd ar ddyfynbrisiau rhwng Wrenvale a'r Cllr T. Strutt. Cynigiwyd gan y Cyng. S Thomas, eiliwyd gan y Cyng. A Hicks, pleidleisiodd pob cynghorydd o blaid.

Archwiliad o ystafelloedd newid Bryn Rovers i'w wneud yfory (10fed Rhagfyr), nid yw'r Cyngor Sir yn barod i anfon contractwr oherwydd materion yswiriant. Gofynnodd Cllr T Strutt am ganiatâd i gyfarwyddo'r clerc i wneud cais am yr yswiriant ar gyfer yr ystafelloedd newid gan fod y difrod wedi'i achosi gan ollyngiad. Cytunodd y cyngor i fynd ar drywydd hyn.

Nododd Cllr T Strutt sut roedd Bryn Rovers wedi anfon dogfen yn ateb pryderon CBCCs a gofynnodd i gynghorwyr wneud sylwadau arni i'w chyflwyno i Bryn Rovers yn y cyfarfod nesaf.

Diweddarodd Cllr H Taylor y CBCC ar safle Maes Elwyn. Sefydlwyd is-grŵp ac aeth trwy'r prosiect yn fanwl iawn, a gwnaed adroddiad. Argymhellodd yr is-grŵp i'r is-bwyllgor asedau na ddylai'r prosiect fynd yn ei flaen. Yna darllenodd Cllr H Taylor bryderon y cynghorwyr am y prosiect. Fe wnaeth Cllr W Churchill hefyd drosglwyddo ei phryderon am oblygiadau ariannol y prosiect. Cynigiodd Cllr H Taylor bleidlais ar dderbyn argymhellion yr is-bwyllgor asedau a bydd yn adolygu'r prosiect yn ddiweddarach, pleidleisiodd yr holl gynghorwyr o blaid hyn.

Cyflwynodd Cllr W Churchill yr adroddiad. Nododd sut yr hoffai'r pwyllgor newid ei enw i "Balchder Bro" a darllen y cylch gorchwyl newydd ar gyfer y pwyllgor. Mae gan y pwyllgor gyllideb o £8,000 i'w wario yn ystod y flwyddyn ariannol. Mae aelodaeth y pwyllgor fel a ganlyn: Cllrs. A Hicks, H Powell, V Morgan a W Churchill.

Nododd Cllr A Hicks y byddai Nigel (Wrenvale) yn ail-baentio'r potiau am ddim a dyfynnwyd ei fod yn ailblannu pob blwch am £20 y blwch, 8 i gyd, i ddod allan o'r gyllideb Balchder Bro. Gofynnodd Cllr T Strutt am eglurhad ar sut y byddai'r gyllideb yn gweithio, nododd Cllr H Taylor fod hon yn drafodaeth i'w chael ar wahân. Nododd Cllr W Churchill sut y byddai'r 'gorgyffwrdd' a'r 'ardaloedd llwyd' yn cael eu clirio unwaith y byddai gan bob is-bwyllgor ei gylch gorchwyl.

Nododd Cllr W Churchill sut y bydd yr pwyllgor Balchder Bro yn gweithio i gynnwys y gymuned yn eu gwaith gymaint â phosibl, gan gynnwys cynnal digwyddiadau lleol.

Cynigiodd Cllr W Churchill, ac eiliwyd gan Cllr. A Dady, wedi'i rannu rhwng Canolfan y Mynydd Du a Chanolfan Gymunedol Ystradowen gyda'r brif swyddfa i fod yn Brynamman, pleidleisiodd yr holl gynghorwyr o blaid.

Argymhellodd Cllr A Hicks y dylai CBCC anfon llythyr at Heddlu Dyfed Powys i dynnu sylw at fater goryrru ar Mountain Road.

Cyfarwyddodd y Cyngor y clerc i gysylltu â Heddlu Dyfed Powys i drefnu cyfarfod i drafod y broblem.
