The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement

1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ £5000 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

2. Over 10% change from previous year:

Line 3 – receipts up 752%: Last year the facilities weren't used for 18 months, so we had relatively no income from users.

Line 4 – staff costs down 63%: We were without a clerk until February 2022.

Line 6- payments down 21%: Play equipment was bought in 2020. Less outgoings this year. We have a number of projects in the pipeline, waiting for contractors

Line 8 – VAT owed to us down 49%: Play equipment bought in 2020. Less outgoings this year.

Line 9 – bank balance up 24%: We have a number of projects in the pipeline, waiting for contractors
