### 4. To discuss increasing financial support and to amend the grant policy.

The committee amended the grant policy maximum to £1000 as had been decided in the previous full council meeting.

A discussion was then had to also include a second Tier for the grants policy to include up to £3000

And to include an emergency section which would be considered outside of the rulings for the other 2 tiers.

**AGREED:** to recommend to Full Council that a policy offering 2 tiers of funding is implemented.

Tier 1: Up to £1000 Tier 2: Up to £3000

Emergency Section which will be looked at on an individual basis.

## 5. <u>To discuss large donations to the Community Centre.</u>

The clerk referred to advice obtained from One Voice Wales regarding the larger sums of assistance given to the Community Centres, which stated 'If there are compelling reasons why one particular organisation receives so much more support than others, then this should be documented and minuted accordingly.'

**AGREED:** to recommend to Full Council that instead of having a separate policy in place the larger amounts to the Centres, this can be recorded accordingly, or they can apply for Tier 2 or Emergency Funding if need be.
