1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £13,331 under section 137. These payments are included within 'Other payments' in the Accounting Statement.



Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Cwarter Bach Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 3: Publication of information
The Council does not publish the information it is required to publish on its website by the Local Government (Democracy) (Wales) Act 2013 and the Local Government and Elections (Wales) Act 2021.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Typographical mis-statement in 2021-22 comparative accounts

Line 9 of the comparative accounts is mis-stated. The Council has entered the closing balance in error leading to an apparent arithmetic error in the accounting statement (Line 11 does not equal the sum of lines 8 to 10). The correct entry for Line 9 is £202,102.

We recommend that the Council checks the consistency and arithmetic accuracy of the Accounting Statement prior to approval.

Certification by the Responsible Finance Officer (RFO)

The Accounts and Audit (Wales) Regulations 2014 require the RFO to certify the accounts by 30 June. The RFO omitted to include the date of her signature. We established that the RFO did in fact sign the annual return as evidence of her certification on 29 June 2023.

We recommend that the Council reviews the annual return for proper completion before submitting for audit.

There are no further matters I wish to draw to the Council's attention.


